- 6. Offer must be valid for a period of at least 30(Thirty) days from the closing date of the Quotation.
- 7. Following Documents must be submitted with tender: a. Updated load test certificate for understanding present lifting capacity b. Load capability chart. Without these papers, tenderer will be treated as non-responsive.
- 8. No public opening shall be held.
- 9. Offer's rates or prices shall be inclusive of profit and overhead charges.
- 10. Rates shall be quoted and, subsequent payments under this work order shall be made in BDT currency. The price offered by the Quotationer, if accepted shall remain fixed for the duration of the Contract.
- 11. Quotationer shall have legal capacity to enter into Contract. Quotationer if Bangladeshi, in support of its qualification shall be required to submit attested photocopies of latest documents related to valid Trade License, TIN with last Financial year tax return acknowledgement slip, 13 Digit BIN. Terms and Conditions for

Crane Service and Payment

- 1. The Crane should be reached at Mymenshingh Power Station, Shambhugonj, Mymenshingh by 16/08/2021 and ready for operation. Work will be started from 8.00AM on 16/08/2021 till 01/09/2021. The crane will leave Mymenshingh Power Station on 01/09/2021 or after completion of the work. The above mentioned schedule may change and will be confirmed minimum 3 days prior to work start.
- 2. The duration of the rental period may be **extended or reduced** if necessary and the charge will be paid pro rata basis.
- 3. RPCL will supply working fuel for the crane only.
- 4. Total operation hour per day of the equipment will be 20.00 hours, if over timework is done beyond 20.00 hrs, overtime charge will be paid pro rata basis. Due to fault of equipment (crane), it should not be considered as working hour/day.
- 5. If the crane remains out of order, the service provider must be made arrangement for an alternative crane of similar capacity.
- The crane operator, rigger & helper must have safety knowledge. If any loss or damages on human or equipment occurs on crane in course of working RPCL will not responsible for those losses on damages.
- 7. The crane and its associated accessories must have up-dated test certificates and digital loading chart.
- 8. The Boom length of the crane must be at least 35 meters and capable of carry 70 ton load on the said length.
- 9. Any issue arises beyond above, will be solved amicably.

10. Payment terms.

- a) Payment will be made through account payee cheque.
- b) Payment: 100% (Hundred percent) payment will be made upon submission of invoice, Challan, Mushok 6.3 along with work completion certificate issued by the Mymensingh Power Station.
- c) Tax will be deducted at source as per GOB Rule. Supplier is responsible for paying the VAT the Mushak Challan-6.3 shall be provided at the time of per submitted bill. Without Mushok 6.3, no payment will be executed.
