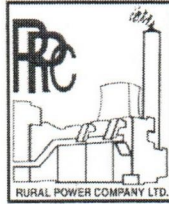

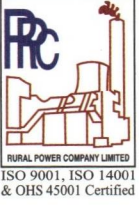

1. The Rural Power Company Ltd intends to procure Supply & Installation Works of Engine Exhaust Duct Expansion Joint for Gazipur 105MW HFO Fired Power Plant, Kadda, Gazipur By own fund to eligible payments under the contract for which this Quotation Document is issued.
2. Detail scope of works and technical specification of the particular item is attached herein.
3. Quotation shall be prepared and submitted using the Terms & condition of 'Quotation Document'.
4. Quotation shall be completed properly, duly signed-dated each page by the authorized signatory and submitted by the date to the office as specified in Para 6 below.
5. No Securities such as Quotation Security (i.e. the traditionally termed Earnest Money, Tender Security) shall be required for submission of the Quotation.
6. Quotation in a sealed envelope or through electronic mail shall be submitted to the office of the undersigned on or before 31.05.2022 at 12:00 Noon. The envelope containing the Quotation must be clearly marked "Supply & Installation of Engine Exhaust Duct Expansion Joint for Gazipur 105MW HFO Fired Power Plant, Kadda, Gazipur." and "DO NOT OPEN" before 31.05.2022 at 12:00 Noon. Quotations received later than the time specified herein shall not be accepted.
7. Quotations received through electronic mail shall be sealed-enveloped by the Procuring Entity duly marked as stated in Para 6 above and, all Quotations thus received shall be sent to the Evaluation Committee for evaluation, without opening, by the same date of closing the Quotation.
8. Quotations must be valid for a period of at least 60 (Sixty) days from the closing date of the Quotation.
9. No public opening of Quotations received by the closing date shall be held.
10. Quotationer's rates or prices shall be inclusive of profit and overhead and, all kinds of taxes, duties, fees, levies, and other charges to be paid under the Applicable Law, if the Contract is awarded.

11. Rates shall be quoted and, subsequent payments under this purchase order shall be made in BDT currency. The price offered by the Quotationer, if accepted shall remain fix for the duration of the Contract.
12. Quotationer shall have legal capacity to enter into Contract. Quotationer (If Bangladeshi), in support of its qualification shall be required to submit attested photocopies of latest documents related to **Latest Trade License, TIN Certificate and 13 Digit BIN Certificate.**
13. Quotations shall be evaluated based on information and documents submitted with the Quotations, by the Evaluation Committee and, at least two (2) responsive Quotations will be required to determine the lowest evaluated responsive Quotations for award of the Contract.
14. In case of anomalies between unit rates or prices and the total amount quoted, the unit rates or prices shall prevail. In case of discrepancy between words and figures the former will govern. Quotationer shall remain bound to accept the arithmetic corrections made by the Evaluation Committee.
15. Supply shall be completed within **90 (Ninety)** days from the date of issuing purchase order. Dismantling & Installation works shall have to be completed within 10 (Ten) days of site handover.
16. Interested tender are requested to visit **RPCL – Gazipur 105MW HFO Fired Power Plant, Kadda, Gazipur** to see the site within the office hour (from Saturday to Thursday 9.00 AM- 5.00PM). The works have to be performed under supervision and as per director of engineer in charge.
17. The Procuring Entity reserves the right to reject all the Quotations or annul the procurement proceedings.
18. The Procuring Entity may extend the deadline for submission of Quotations on justifiably acceptable grounds duly recorded subject to threshold of ten (10) days pursuant to Rule 71 (4) of the Public Procurement Rules, 2008.





Terms and Conditions

1. Terms and Conditions contained herein shall be binding upon both the RPCL and the Contractor for the purpose of administration and management of this Contract.
2. Supply shall be completed within **90 (Ninety)** days from the date of issuing purchase order. Dismantling & Installation works shall have to be completed within 10 (Ten) days of site handover.
4. The Contractor shall have to submit a work Schedule showing sequence of work flow chart for each day.
5. The Contractor shall arrange adequately/manpower, Tools & Tackles in order to complete the work within the stipulated time.
6. The Contractor shall be entitled to an extension of the Work Completion Schedule if the RPCL delays in site hand over or if Force Majeure situation occurs or for any other reasons acceptable to the RPCL on justifiable grounds duly recorded.
7. All works under the Contract shall at all times be open to examination, inspection, measurements, testing, commissioning, and supervision of the RPCL authorized representative.
8. The RPCL shall check and verify the works done by the Contractor in conformity with the BOQ and notify the Contractor of any Defects found.
9. If the works are found to be defective or otherwise not in accordance with the BOQ /specifications, the RPCL may reject the supplies by giving due notice to the Contractor, with reasons.
10. The Contractor shall be entirely responsible for payment of taxes, duties, fees, levies, and other charges to be paid under the Applicable Law.
11. Notwithstanding any other practice, the payment shall be based on:
 - a) 50% (Fifty percent) Payment of the Materiel price shall be made on the basis of actual quantity supplied of each item of goods in accordance with the price schedule and specifications and getting receiving report & quality certificate issued by the Gazipur 105MW HFO Fired Power Plant.
 - b) Remaining 50% (Fifty percent) amount will be paid after Successful completion of the works and getting Work completion certificate issued by the Gazipur 105MW HFO Fired Power Plant
12. The amount of Liquidated Damages is 0.1% per day of the uncompleted works after expiry of the Intended Completion Date or extended Intended Completion Date, as applicable, but not more than 10% of the uncompleted works value.
13. The minimum Warranty Period is 01(One) Year from date of completion of the work.
14. The Contractor shall keep the Procurement Entity harmless and indemnify from any claim, loss of property or life to himself/herself, his/her workmen or staff, any staff of the Procurement Entity or any third party while delivering the Goods and related services .



15. Damage to the Works during the Warranty Period shall be remedied by the Contractor at his own cost, if the damage arises from the workmanship by the Contractor.
16. Scope of Works and quantities ordered may be varied as per requirements of the situations and as per direction at the engineer in charge.
17. The contractor shall arrange all necessary safety tools & equipment for personnel who will be works at site.
18. **The RPCL authority shall amend the work order incorporating required approved changes subsequently introduced to the original Terms and Conditions in line with Rules, where necessary.**
19. The RPCL and the Contractor shall use their best efforts to settle amicably all possible disputes arising out of or in connection with this Contract or its interpretation.
