8	RPCL-NORINCO Intl Power Limited (RNPL), a joint venture company of state-owned Rural Power Company Limited (RPCL) and Chinese state-owned company NORINCO International Cooperation Limited (NORINCO), is jointly implementing Patuakhali 1320 (2×660) MW Coal Fired Thermal Power Plant at Dhankhali Union, Kalapara Upazilla, Patuakhali District.
9	Only eligible tenderers with the following key qualifications, summarized from the tender document, are invited to participate: I. Minimum number of years of overall experience in the field of Ash and /or Gypsum Handling and/or Processing System and related services shall be: Ten (10) years as on Tender Opening Date. II. Minimum specific experience in installation/facilitation and/or operation of Pneumatic Ash Handling System and/or Gypsum Handling System shall be: Five (05) years as on Tender Opening Date. III. Minimum Capacity for end utilization shall be: 1,000 tons per day . IV. The minimum value of Commodity purchased in the last three years under maximum Three Contracts shall be BDT 100,000,000.00 (Ten Crore Taka only) V. The average annual turnover of the Tenderer of last three (3) financial years is 200,000,000 (BDT Twenty Crore Only) VI.
