**Duties and Responsibilities:**

The Managing Director is the Chief Executive Officer of the Company responsible to the Board of Directors as per provisions of the Articles of Association of EGCB Ltd. The position shall be responsible for overall administration, finance, technical matters, corporate planning and business development of EGCB Ltd. Other important tasks are to co-ordinate activities regarding operational and functional systems of the organization, liaise with national and international financial institutions/entities and development partners for sourcing, sanction and mobilization of fund for power plant/development projects, negotiate with stakeholders etc.

**Educational Qualifications:**
