Executive Director (Operation & Maintenance), No. of Post: 01

The Executive Director (O&M) is responsible for all sorts of Operation & Maintenance activities of the company reporting to the Managing Director. It is a strategic level position. The incumbent shall act as a member of the management team of the company to assist the Managing Director for the overall performance of Operation & Maintenance activities of the company.

Key Responsibilities:

a) Managing, Directing, Coordinating and Supporting day to day operation & maintenance activities of power plants as well as formulate and implement organization strategies, changes and tactics designed to maximize

Plan to attain maximum plant availability, equipment reliability and to reduce forced outages and develop long-term schedule maintenance programs, improvement of processes, systems and governance standards;

c) Optimize maintenance programs by evaluating and establishing best practices in predictive, preventive and corrective maintenance and ensure maintenance of optimum inventory of spare parts for the smooth operation of the power plants, plan to mitigate environmental impact resulting from power plant operation, provide the technical recommendations to keep the power generation cost competitive and work closely with Top Management to run the company effectively & efficiently.

Required Qualification:

At least graduate in Mechanical/Electrical/Electrical & Electronic Engineering from any recognized university/institution.

No third Division/Class at any stage of the academic career shall be acceptable. Candidates passed in the grading system must possess at least a GPA/CGPA 3.0 on a scale of 5.0 and GPA/CGPA 2.50 on a scale of 4.0.

At least 05(five) years experience in the position not below the rank of Superintending Engineer or equivalent in the relevant field.
